PUBLIC TRANSPORTATION MILLAGE

MACOMB COUNTY PUBLIC TRANSPORTATION MILLAGE RENEWAL
IF APPROVED, THIS PROPOSAL WILL RENEW THE 0.33 MILLS LEVIED BY MACOMB COUNTY IN 1995, 1996 AND 1997 AND ALLOW CONTINUED SUPPORT IN AID OF THE SUBURBAN MOBILITY AUTHORITY FOR REGIONAL TRANSPORTATION (SMART) AND ITS PURPOSES OF SERVING THE ELDERLY, HANDICAPPED AND GENERAL PUBLIC OF MACOMB COUNTY.

SHALL THE 0.33 MILL, (33 CENTS PER \$1,000 OF TAXABLE VALUE), INCREASE ON THE LIMITATION ON THE AMOUNT OF TAXES IMPOSED ON TAXABLE PROPERTY IN MACOMB COUNTY, WHICH EXPIRED WITH THE 1997 TAX LEVY, BE RENEWED FOR FOUR (4) YEARS, 1998, 1999, 2000 AND 2001, INCLUSIVE, FOR THE PURPOSE OF MAKING CONTRIBUTIONS IN AID OF THE SUBURBAN MOBILITY AUTHORITY FOR REGIONAL TRANSPORTATION ("SMART") AND ITS PURPOSE OF SERVING THE ELDERLY, HANDICAPPED AND GENERAL PUBLIC IN MACOMB COUNTY?
