


Judge of the District Court - District 39 (Incumbent Position)




Judge of the District Court - District 40 (Incumbent Position)




Judge of the District Court - District 41A (Incumbent Position)




Judge of the District Court - District 41B (Incumbent Position)




Judge of the District Court - District 42 - Division II (Incumbent Position)








Village of Armada - President




Village of Armada - Clerk


