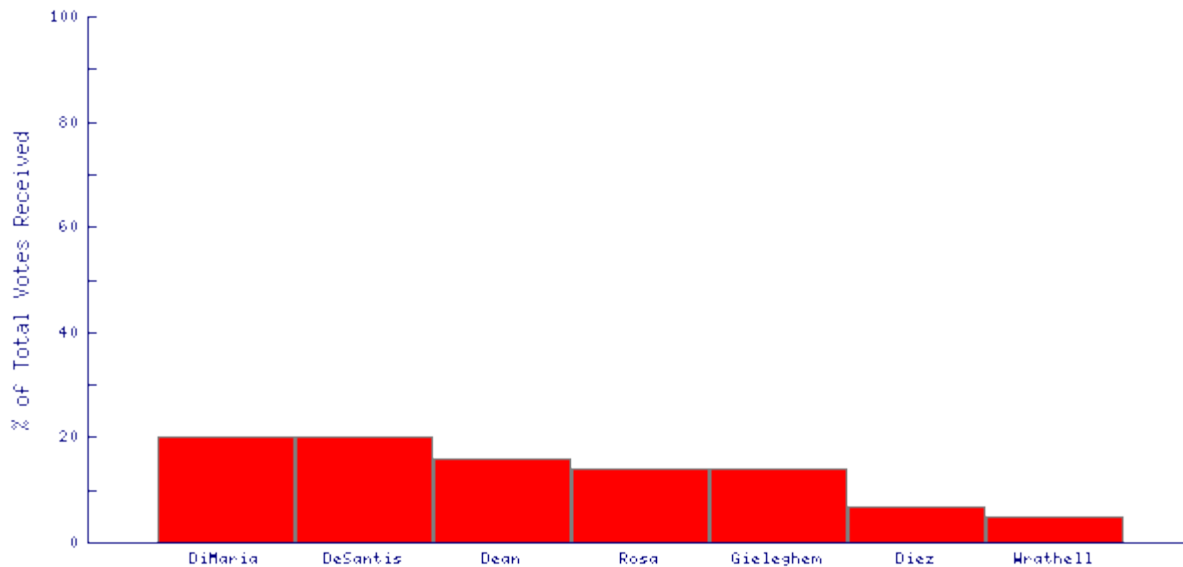

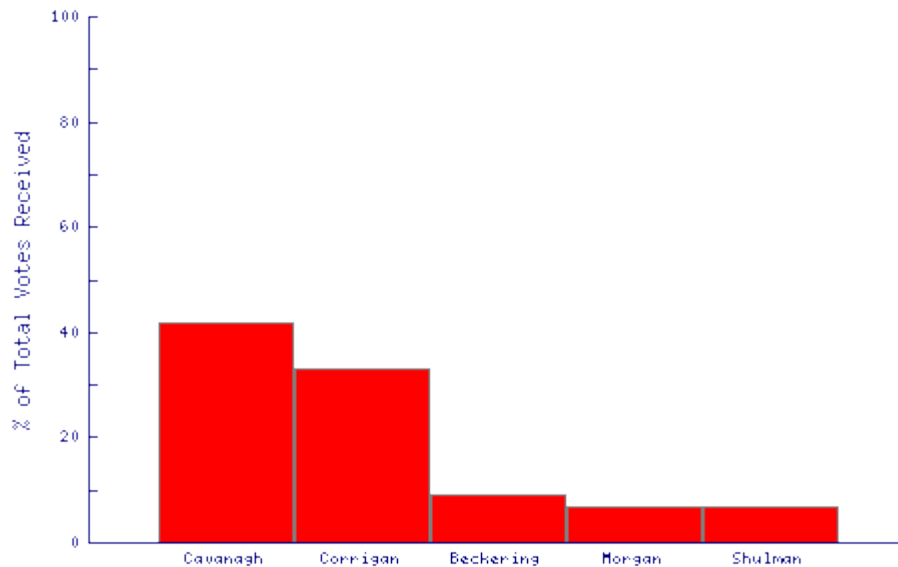

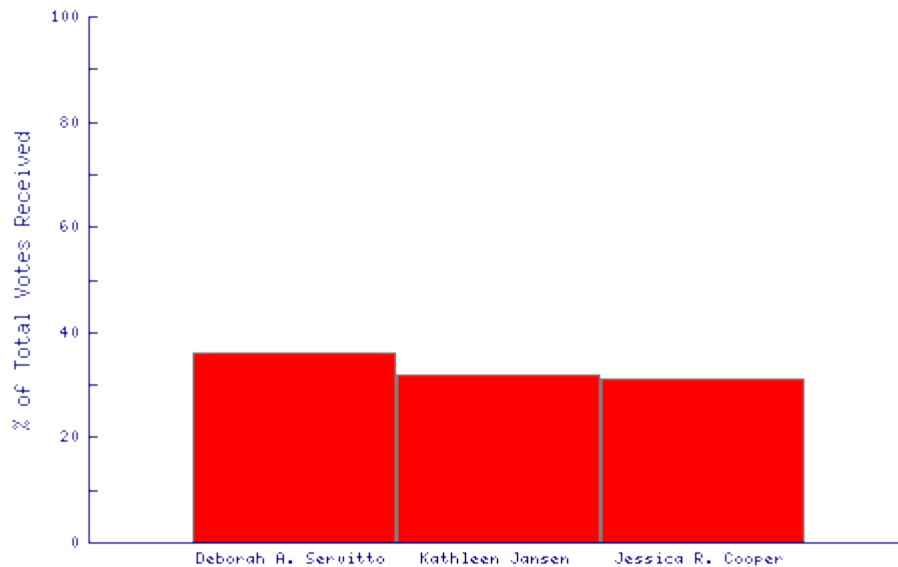


Judge of the Court of Appeals - 2nd Dist. (Incumbent Positions)

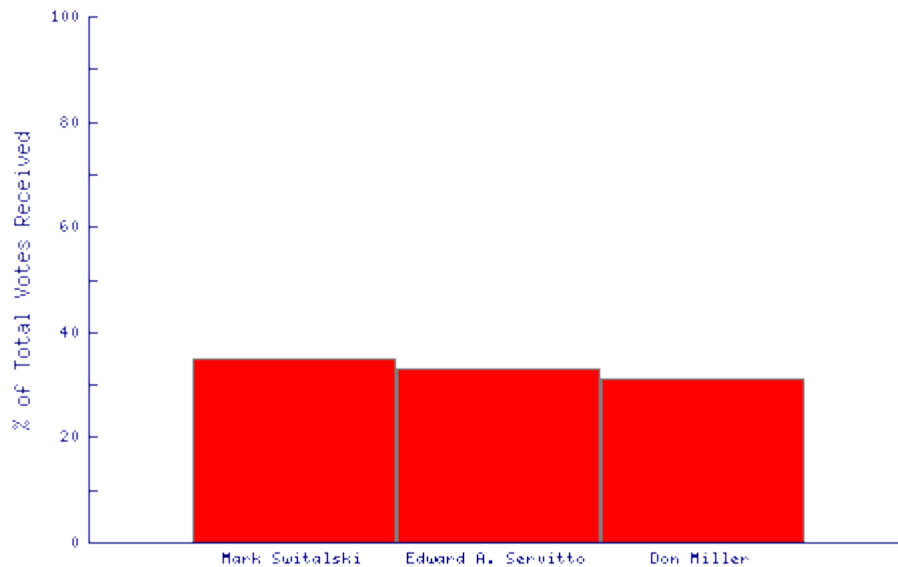

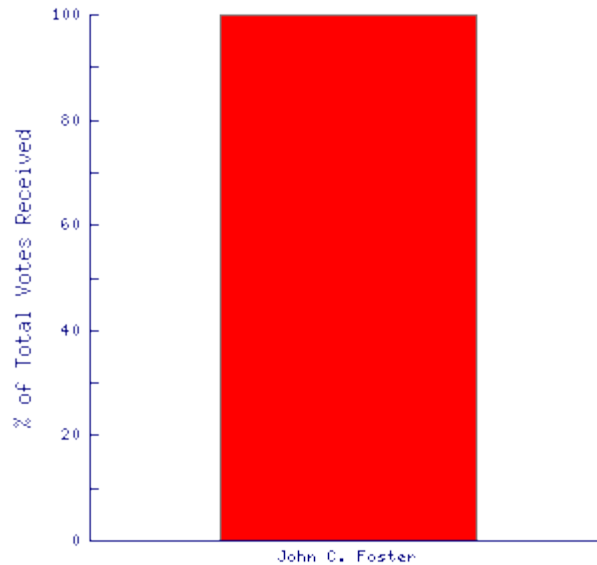

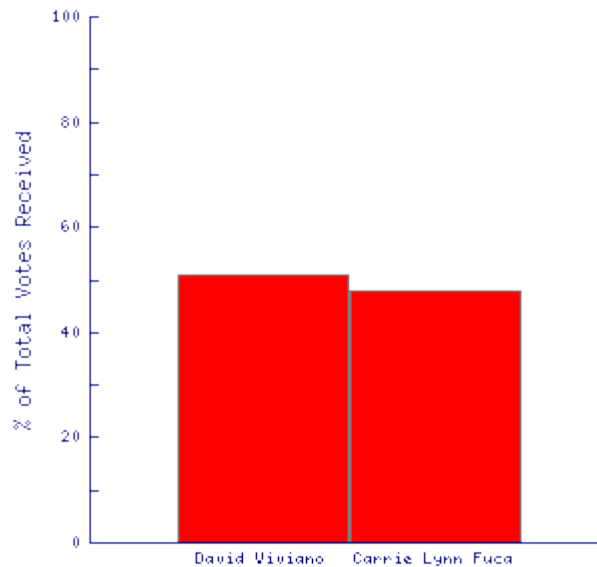

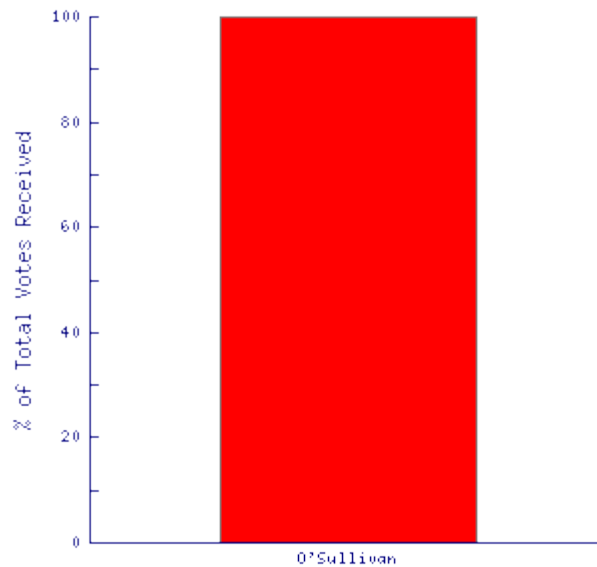


Judge of the Probate Court (Incumbent Position)

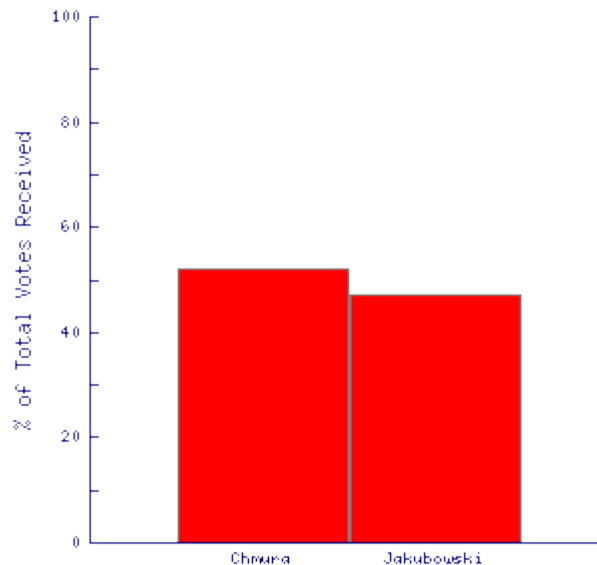


Judge of the District Court - District 37 (Incumbent Position)

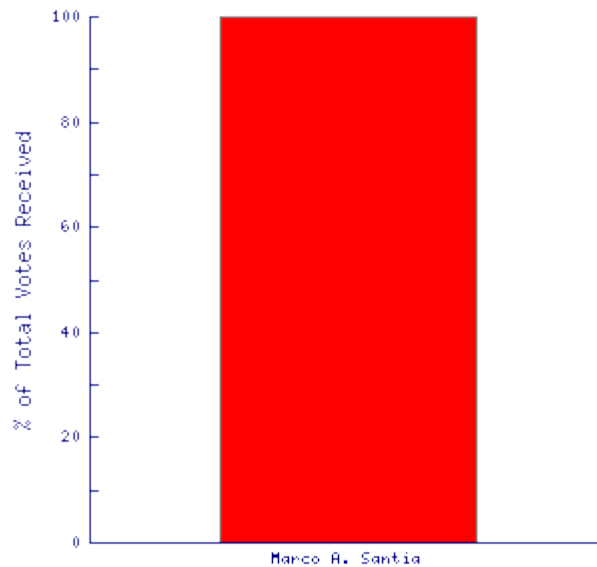


Judge of the District Court - District 39 (Incumbent Position)
