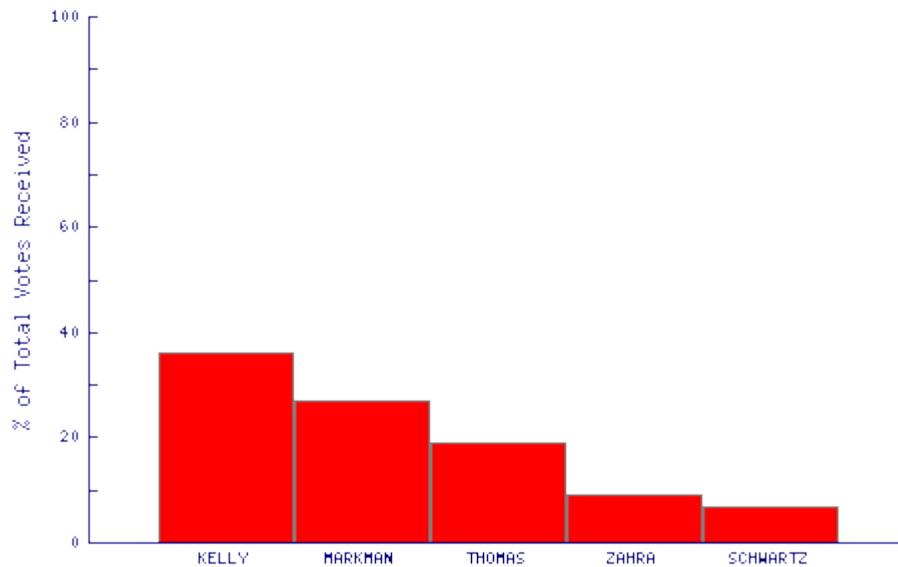

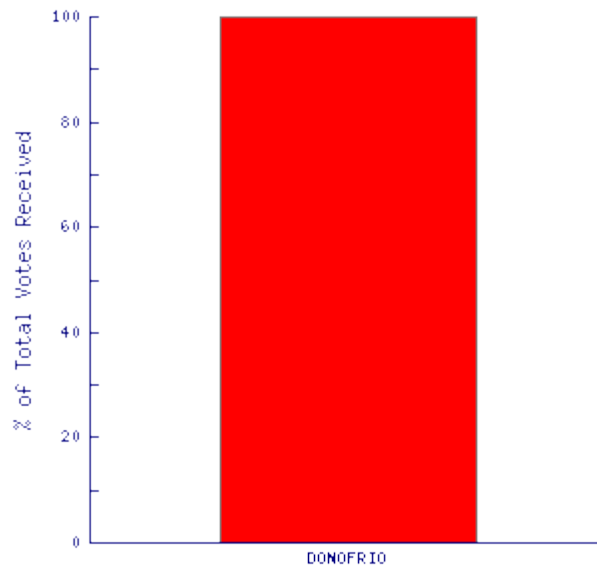


2nd District Judge of the Court of Appeals (Incumbent)

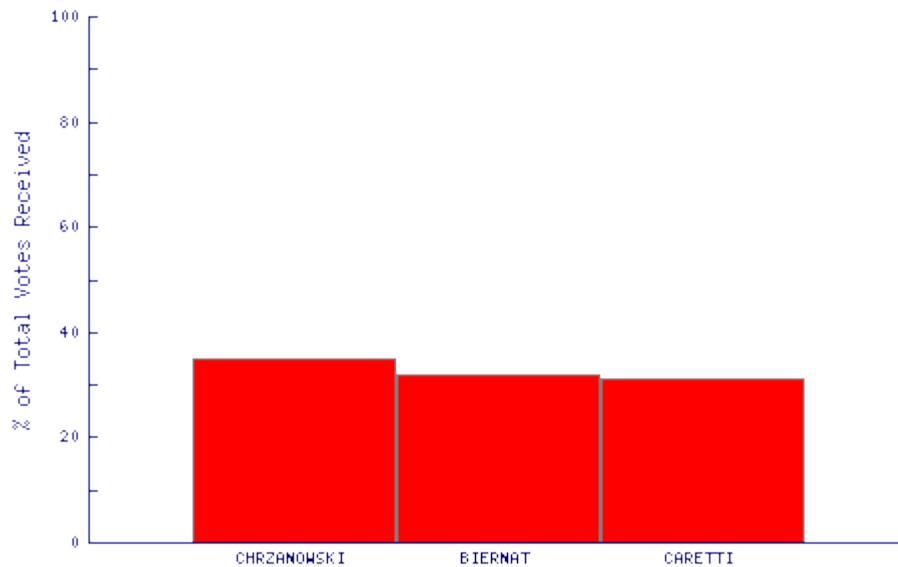

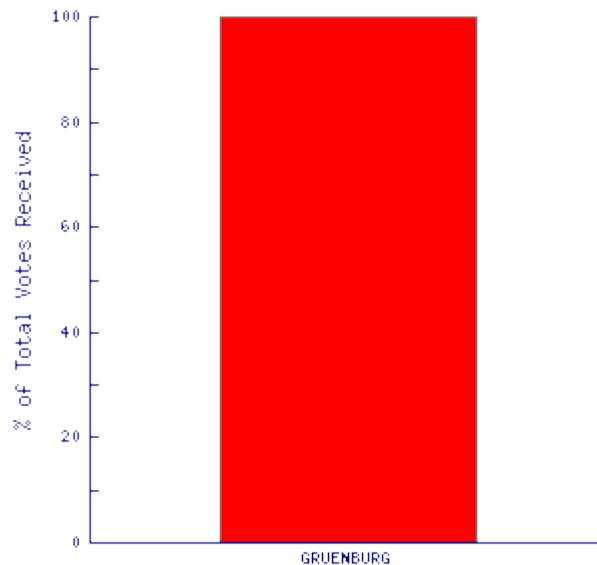
