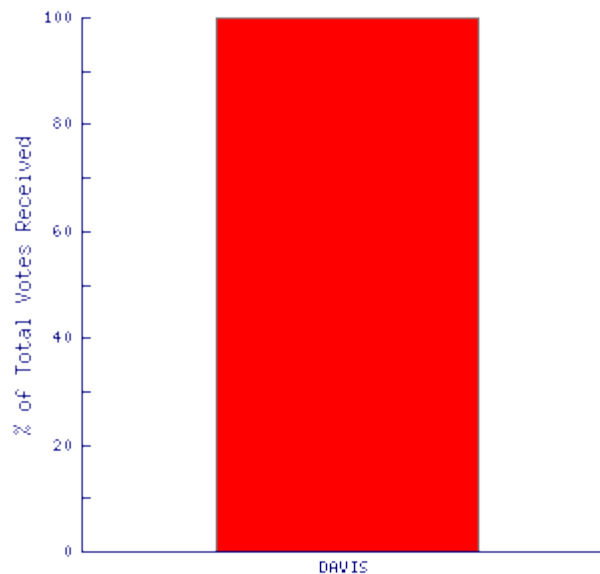

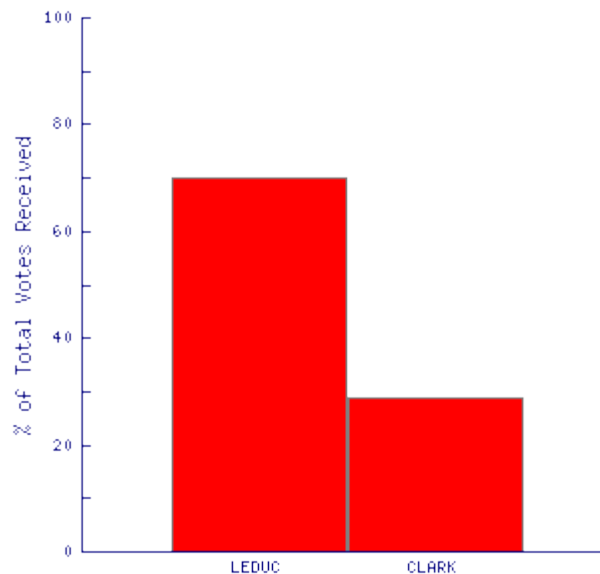


42nd District 1st Division Court Judge (Non-Incumbent)
