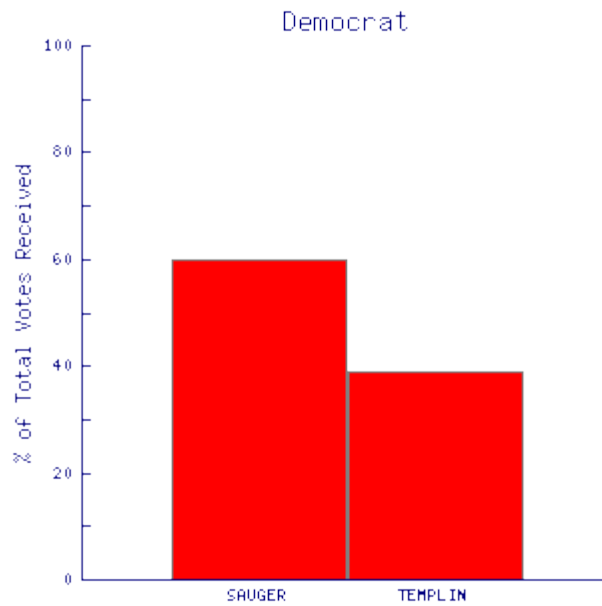

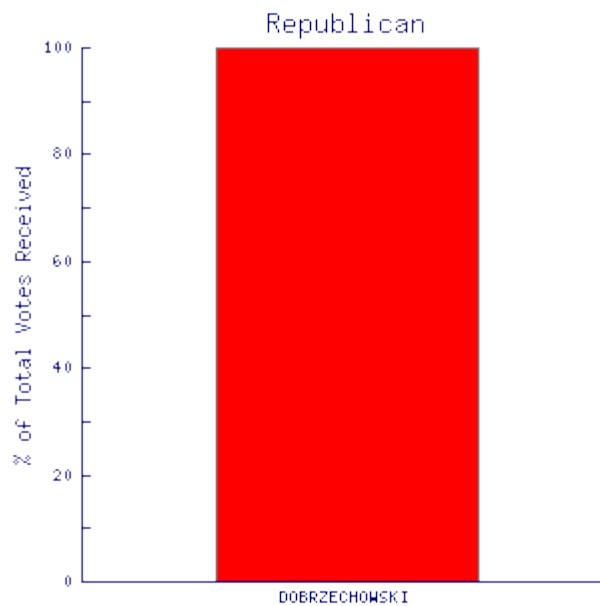

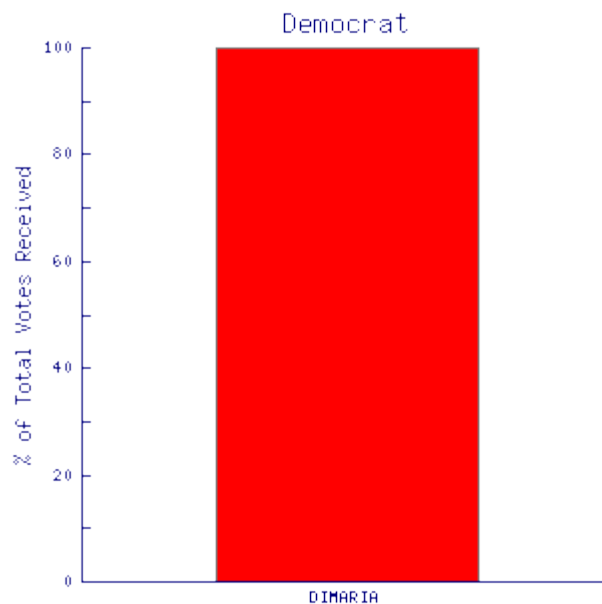
County Commission 3rd District One 2-year term

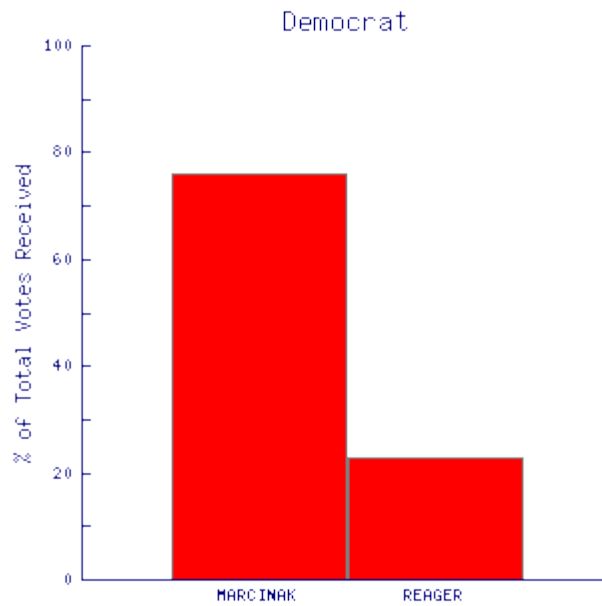

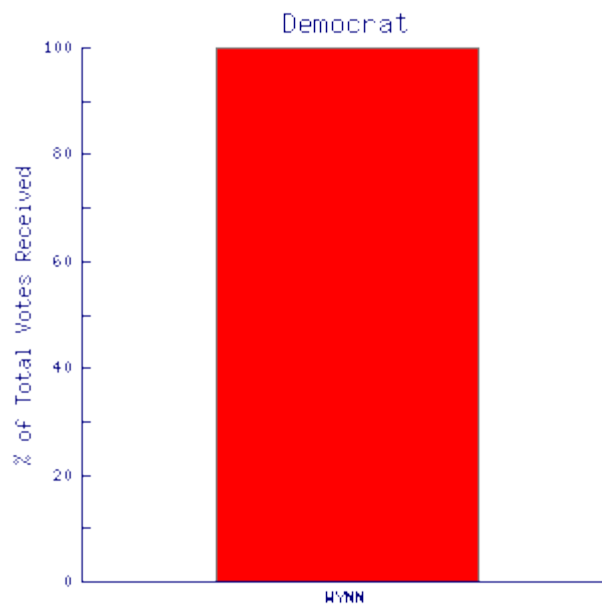

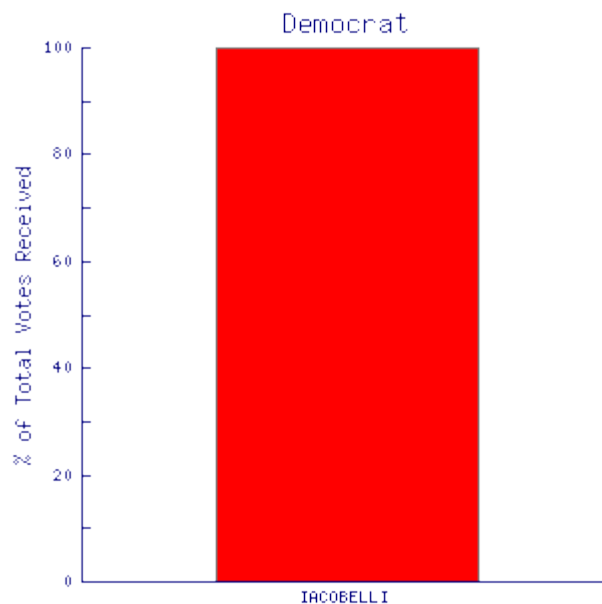
