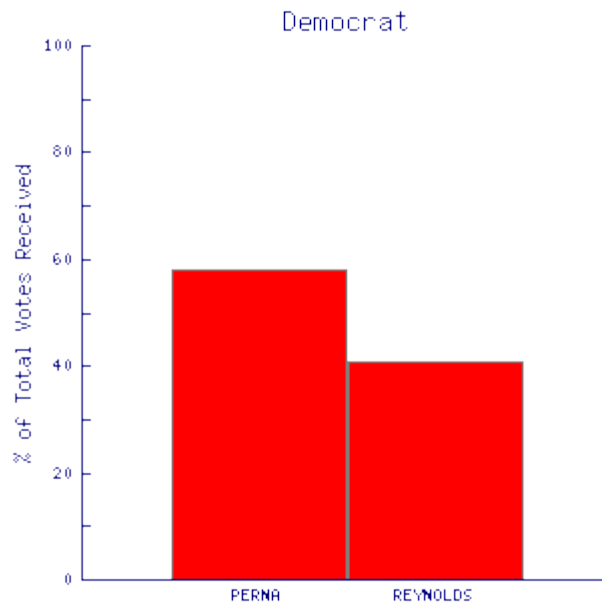

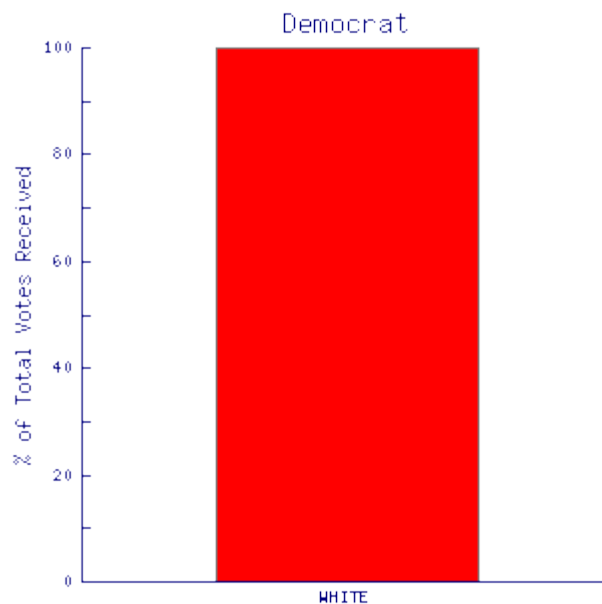

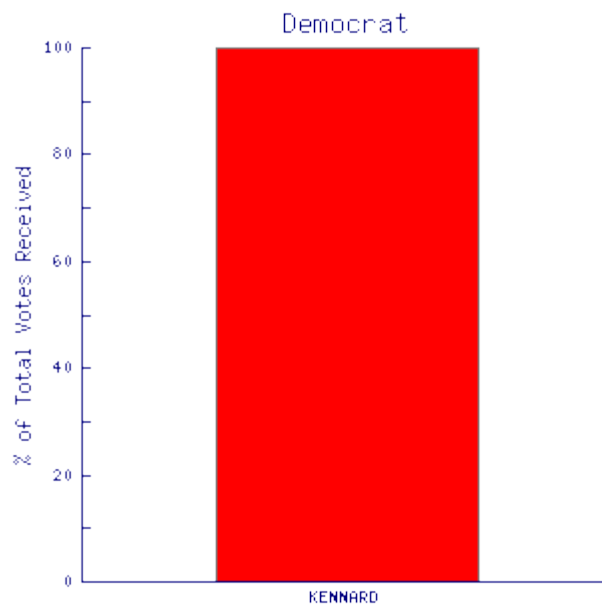

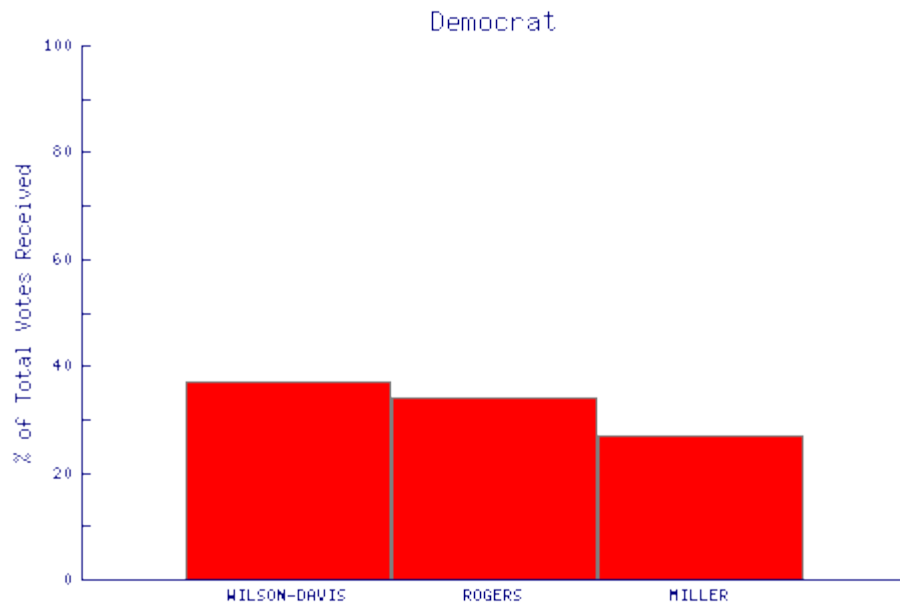

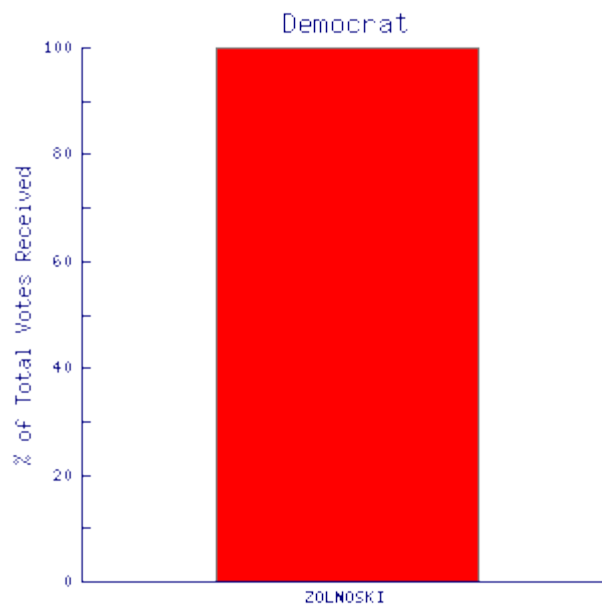
County Commission 26th District One 2-year term
